We have had many requests to open the landfill at hours other than regular landfill hours. Meeting these requests has increased the landfill operator costs to the Town and, henceforth, there shall be a surcharge of \$30.00 per hour, with a minimum 3 hours, for those who wish the landfill operator to attend at the landfill at other than the hours listed above.

Town crews will continue to pick up composting material from yards around town until there is no more debris to be collected.

*We wish to caution all those delivering debris to the landfill site to ensure that your load is secure. The Rural Municipality of Progress has hired students to clean the ditches of the #711 between town and the landfill site and cooperation between the town and rural municipality is difficult when town residents do not respect the rural municipality's desire to maintain the appearance of their roads. Each of us has a responsibility to ensure that we do not leave a string of garbage from town to the landfill site.*

Remember - All debris delivered to the landfill must be sorted.

To expedite the delivery of refuse to the landfill, landfill users should sort their materials at home into the following categories:

- a) Wood, unpainted and untreated only;
- b) Compostibles material, which includes all peelings, garden refuse, leaves, etc., but does not include containers or bags in which the material may be delivered to the landfill (If you deliver leaves, etc. to the landfill in plastic bags or other containers, you must empty the bags or other containers and place them on the appropriate pile or in the appropriate area.)
- c) Metals, including metal bed frames; and
- d) All other household garbage

signs have been erected at the landfill site indicating that there shall be no trespassing and no scavenging. In addition to liability issues that may arise from trespassers or scavengers, we currently have made arrangements with a contractor to remove all metals from our landfill site at no cost to the municipality. This is possible because the contractor receives the benefit of any metals that may be of value. We wish to continue this arrangement and scavengers who remove these types of metals put the Town at risk of losing this contractor and either having to accept the services of contractors who charge for their services or of refusing to accept metals at the landfill site.

**BYLAW NO. 2018-08**

**A BYLAW TO PROVIDE A WASTE MANAGEMENT PROGRAM, THE DISPOSAL OF WASTE MATERIAL AND A FEE SCHEDULE FOR THE LUSELAND LANDFILL**

The Council of the town of Luseland, in the province of Saskatchewan, enacts as follows:

1. This Bylaw may be referenced as "The Waste Management Bylaw.
2. In this bylaw:
  - (a) "Compost Material" means garden waste, grass clippings, leaves, twigs, fruit and vegetables, but does not include branches, trees or household waste.
  - (b) "Council" means the Council of the Town of Luseland.
  - (c) "Designated Users" means the residents of the Town Luseland and also the residents of the neighboring municipalities that have a funded agreement with the Town of Luseland.
  - (d) "Hazardous Waste" means oils, fuels, lubricants, antifreeze, oil base paints, solvent based cleaners, herbicides, pesticides, noxious chemicals and their containers and other material or substance that is considered harmful to the environment. Contaminated soil or material with any of the above is also considered hazardous waste.
  - (e) "Household Waste" includes food scraps, packaging and general household waste that cannot be recycled.
  - (f) "Luseland Landfill" and "Landfill" refer to a portion of the NW10-36-24-W3 that is designated for the handling and disposal of waste material.
  - (g) "Long Box" refers to a truck box over 6 feet in length but not longer than 8 feet from cab to tailgate.
  - (h) "Metals" refers to but is not limited to appliances, water heaters, water softeners, furnaces and any other metals and equipment.
  - (i) "Municipality" refers to the Town of Luseland.
  - (j) "Non-Designated Users" refers to anyone not mentioned in (c).
  - (k) "Recyclable" means any item or material that can be diverted from waste for reuse or reprocessing.
  - (l) "Recycle Depot" refers to an area or building, designated by Council, where recyclable material can be deposited.
  - (m) "Recycling Program" means opportunities provided by the municipality or other recognized organization that diverts recyclables from the landfill.
  - (n) "Rubble" means broken cement, pavement, rock, bricks or similar items.
  - (o) "Short Box" refers to a truck box not longer than 6 feet from cab to tailgate.
  - (p) "Wood" refers to branches, trees and untreated lumber.
3. Designated Users are encouraged to remove all Recyclables from their waste and deposit them with the appropriate Recycle Program.
4. Waste Material accumulated and stored for the purpose of collection shall be:
  - (a) clearly divided between household waste and compost material as to accommodate the collection of each; and
  - (b) in the case of Household Waste, be kept in plastic or metal waste receptacles or tied in plastic bags not exceeding 17 gallons by volume or 40 pounds by weight. Loose garbage deposited in waste receptacles will not be collected.
5. Containers used for the collection of waste material shall be:
  - (a) securely placed on a stand or hanger in a manner that will prevent it being accessed by animals, except during the weekly collection time;
  - (b) kept or placed in a convenient site for removal by an authorized person, and maintained in a sanitary and serviceable condition.
6. Council may order a person to obtain or provide a proper waste receptacle and/or stand, and if that person fails to comply with the order within the specified time as set out in the order, Council may provide such a receptacle and/or stand at the expense of that person.
7. The burning of waste material is strictly prohibited within the Municipality.

8. Waste material shall be removed to the Luseland Landfill by:
  - (a) a person who has a contract with the Municipality for the purpose of waste removal;
  - (b) a municipal employee; or
  - (c) a person having received permission from the Municipality; or
  - (d) Designated Users or their designate providing they adhere to the regulations and fees as set out in Schedule "A" attached.
9. The collection, removal and disposal of wastes, subject to modification as deemed necessary by Council, shall be:
  - (a) once a week in all residential zones; and
  - (b) twice a week in all commercial zones.
10. All owners or occupants of land or buildings within the Town of Luseland shall pay to the Town, on a quarterly basis in advance, the charges as set forth in Schedule "B" attached. Fees shall be shown separately as a "Waste Fee" on the quarterly Water and Sewer Notice. Accounts shall be paid with a period of thirty days from the date of which such bills are mailed.
11. Waste collection, removal and disposal services shall commence with the connection of water and sewer services pursuant to the Water and Sewer Bylaw.
12. When the whole or any part of the charges payable to the Town of Luseland as set out in Schedules "A" and "B" remain unpaid on December 31<sup>st</sup> of the year in which the charge was incurred, these charges may be added to and become part of the taxes on the land and buildings in respect of which the charges were levied.
13. The municipality reserves the right to refuse to collect or remove any of the following waste:
  - (a) any refuse that does not have Compost Material separate from Household Waste;
  - (b) any Recyclable item acceptable at a Recycling Depot;
  - (c) any receptacle or waste item that is considered overweight or oversized;
  - (d) branches and trees;
  - (e) Hazardous Waste;
  - (f) any waste material or item not accepted at the Luseland Landfill; and
  - (g) any other waste material or item that is considered unsuitable for collection.
14. The following practices are strictly prohibited:
  - (a) the dumping of waste material on any property within the Municipality, whether public or private, that is not designated as a site to accept waste material; and
  - (b) the dumping of waste material on the ground of the recycling depot or the dumping into the recycling bins of waste material that is not designated for recycling by the Municipality.Any person dumping waste as set out in 14(a) or 14(b) is guilty of an offence and is subject to the penalty provisions.
15. The Luseland Landfill, as identified in 2(f), is to provide waste handling and disposal services for the residents of the Town and other Designated Users as determined by Council.
16. The hours of operation of the Landfill may vary by season and availability of staff and shall be advertised by public notice.
17. The main gate is the only permitted entry to the Landfill. Any person entering the landfill through a point other than the main gate is guilty of an offence and is subject to the penalty provisions.
18. Trespassing or making use of the landfill after designated hours is strictly prohibited. Any person trespassing or making use of the Landfill outside designated hours is guilty of an offence and is subject to the penalty provisions.
19. Scavenging for any material at the landfill is strictly prohibited. Any person entering scavenging for any material at the Landfill is guilty of an offence and is subject to the penalty provisions.
20. The Municipality shall ensure that the Landfill is supervised during designated hours and no one is allowed into the landfill without supervision.

21. The Landfill shall be segregated in order that different types of waste can be placed in separate areas. The attendant shall ensure that all users of the Landfill deposit their waste in the appropriate area.
22. All loads taken to the Landfill must be adequately restrained by being tied down to covered with a tarp or other method of containment, or the attendant will refuse to accept the waste materials.
23. Burning of waste at the landfill is strictly prohibited with the exception of the site designated for untreated lumber, tree branches and trees. Only a representative of the municipality is allowed to ignite the designated site.
23. The attendant shall keep a record of who brings waste material into the landfill, the type and amount of waste deposited, any user fees collected or to be billed and any other pertinent information that may be required.

Excepting the provisions pertaining to charges as set out in Section 12, any person who contravenes any provision in this bylaw is guilty of an offence and, upon summary conviction, shall be subject to a penalty as follows:

First Offence:	\$50.00
Subsequent Offence:	\$500.00 each

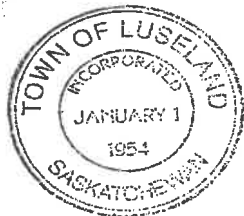
A violator of any section of this bylaw, having been served with a Notice of Violation by a Peace Officer, shall be subject to a penalty as follows:

First Offence:	\$50.00
Subsequent Offence:	\$100.00

The violator may, during office hours, voluntarily pay the penalty at the Luseland Town Office.

Waste Management Bylaw No. 2016-07 is hereby repealed.

This Bylaw shall come into force and take effect on the day of approval by the Council of the Town of Luseland.
